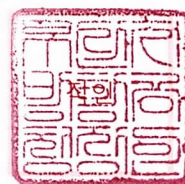





Domestic AMO	A certificated approved maintenance organization located in Republic of Korea
Exemption	An Authorization that permits an alternate means of compliance with a specific FSR.
